## TERMS AND CONDITIONS

### 1. Application and Confirmation of Participation

The application for participation shall only be possible through the completion of official contract form. It has to be duly completed with true and correct information and signed by an authorized person-in-charge of the exhibiting company with its company stamp. The application shall only be confirmed by the Organizer once received and acceptance by the Exhibitor of the Terms and Conditions of the Contract.

### 2. Payment

- a. Once the contract form has been accepted by the Organizer, an official electronic invoice will be sent to the Exhibitor via e-mail, attention to the person-in-charge in the participation.
- b. The payment information is given on the first page and the payment transaction must be done through the following:
  - i. The exhibitor can pay full payment within 45 days from the invoice date.
  - ii. If payment is not in full, the exhibitor is required to pay 50% of the total cost stated in the invoice within 45 days from the invoice date.
  - iii. The remaining 50% is required to pay until January 31, 2020.
- c. For each payment made, the exhibitor is required to send a scanned copy of bank deposit receipt to the Organizer as a confirmation of the payment.
- d. The cost of acquired booth package is to be increased by 7% Value Added Tax as specified in the invoice.

### 3. Cancellation and Withdrawal made by the Exhibitor and by the Organizer to the Exhibitor

- a. The exhibitor is allowed to withdraw from the Exhibition given the condition that any payment made to the Organizer will not be refunded. In the case of a cancellation made less than 60 days before the opening day of the show, 100% of the total payment will be due from the exhibitor for the loss of the rental.
- b. If the Exhibitor shall fail to observe or comply with any of the terms and conditions contained herein or if the Exhibitor shall fail to pay any of the required payment at the time specified, then the Organizer shall reserve the right to cancel the contract by sending electronic notice to the Exhibitor. The Organizer shall reserve the right to resell or reallocate the booth space of the Exhibitor in default to other interested Exhibitor.

### 4. Exhibit

Only printing or packaging products/services are allowed to be exhibited in the show. All exhibiting products/services and promotional materials are only allowed to be displayed within the acquired booth.

### 5. Booth Construction and Decorations

The Exhibitor who desires for additional booth decorations is required to submit their booth design to the Organizer for approval at least 1 month before the exhibition.

### 6. Damages to Booth

The Exhibitor will be liable for any damage to the walls, floor carpet, furniture, lightings, or to any part of the Exhibition Hall in which their exhibiting items/services are placed.

### 7. Sub-Letting of Booth (Sublease)

The Exhibitor is not allowed to sub-let the booth allotted to them to other parties without the approval consent of the Organizer.

### 8. Unexpected Changes

The Organizer reserves the right to change the venue, duration of the Exhibition, and make a space reallocation if unexpected occurrences happened. However, the agreement to participate shall remain valid as the Exhibitor is informed in the changes. The Organizer is not liable to give any compensation to Exhibitor as a result of such changes.

### 9. Data for Show Directory and Artwork

The exhibitor's information stated on the Contract shall be used in the Show Directory. The Organizer shall be permitted to publish exhibiting company's artwork and products information in the Show Directory. The artwork must be submitted within the time specified by the Organizer. The Organizer shall also be permitted to take photos of products and booth during the exhibition to be used for public promotion for the future exhibition.

### 10. Movement of Exhibits

- a. The responsibility and expenses for the transport of exhibits to the Exhibition venue shall be taken by the Exhibitor.
- b. The arrangement for storage and warehousing of exhibits shall be managed by the Exhibitor.
- c. The showcased exhibits shall be removed by the Exhibitor from the Exhibition Hall within the period stipulated by the Organizer and shall indemnify the Organizer against any loss or damage to the Exhibition Hall.

### 11. Fire Regulations

To avoid casualties, all materials to be used in booth and exhibition constructions must be nonflammable. If the Authorities shall find any Exhibition Facilities hazardous for such construction, the Exhibitor will be forced to stop from doing so.

### 12. Security, Insurance, Liability and Risks

- a. The Organizer shall be responsible for the security of the Exhibitors and visitors. However, the Organizer shall not be held responsible for any loss or theft of exhibits at the Exhibition hall during the build-up, exhibition and dismantling period. Organizer shall also not be held liable for any loss or damage to exhibits or any belongings of the Exhibitors.
- b. Each party shall indemnify, defend and hold blameless the other, from and against all claims, demands, suits, losses, liabilities and costs, including attorneys' fees arising out of any alleged breach of the foregoing warranties or any alleged violation of copyright or other intellectual property rights.

### 13. Failure of Services

The possible reasons for cancellation, suspension or reduction of duration of the scheduled Exhibition are the ff.:

- a. Force Majeure
- b. Acts of War or Military Activity
- c. Inclement Weather, Earthquake or Fire
- d. Or any circumstances beyond Organizer's control

In case of cancellation, suspension or reduction of the event, the amount paid to the Organizer may be refunded at the sole discretion of the Organizer considering the entire sum left after expenses have already incurred for the Exhibition.

### 14. Modification of Agreement

If the Exhibitor desires to modify this Agreement, he must send the modification(s) via e-mail to the Organizer which is subject for approval. If both parties agreed, the modification copy must be signed by both parties.

### 15. Supplementary Clauses

The Organizer shall reserve the right to revise the Terms and Conditions of the contract. Any changes will be considered part of the Exhibitor Contract and shall be binding on with the Exhibitors.
